1. **Course, Title:** *Society and corruption*  
**Sem.:** 4<sup>th</sup>  
**Code:** 300187

Description:

The aim of the course is to introduce students to the scientific subject of corruption. In this context, students are asked to handle starting points and questions such as: what does corruption mean? How does her hearing sound in human cultures? Is this a controversial identifiable concept, a complex phenomenon or a science? What does homo corruptus interpret, manage and pursue in space and time? Societies without corruption mean societies without people? Which subjective and moral meanings of people are transformed into manifestations of social, political, economic and cultural necessity, shaping the ideotypes of corruption in their societies?

Fields of Teaching:

- Students are introduced into the field of reflection on the complexity of all human actions around the world, for which their relationship with the term corruption is sought.
- Students enter the wording and analysis of corruption theory. The starting point is the analysis of the coordinates needed for the mapping of this theory, as well as the value study of the phenomenon.
- Students are invited to approach, understand and overcome all the trappings of older and modern approaches to the phenomenon of corruption by scholars around the world. A set that reveals the weaknesses in the approach to historical, social, cultural, cultural and customary conditions that lead to the effect of corruption formation as a global phenomenon within a local and time frame in each country around the world.
